

## FX Black Rhino Society - Terms and Conditions

Welcome to FX Black Rhino Society ("the Society," "we," "us," or "our"). These Terms and Conditions ("Terms") govern your participation in our investment membership packages. By investing with us, you agree to comply with these Terms.

### 1. Investment Membership Packages

#### A. iFund Premium Membership Package

- Investment Tiers & Monthly Interest:
  - Ghc5,000 – Ghc20,000: 5% monthly interest
  - Ghc25,000 – Ghc100,000: 7% monthly interest
  - Above Ghc100,000: 8% monthly interest
- Investment Term: 6 months
- Principal Protection: Your initial investment is protected and will be returned at the end of the term.
- Withdrawals:
  - Early withdrawals are permitted but subject to a 2% penalty of the principal amount.
  - Full withdrawals (principal + accrued interest) are only available at the end of the term.
